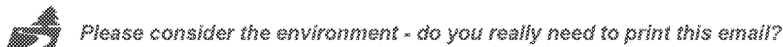

Hope that covers what you need.

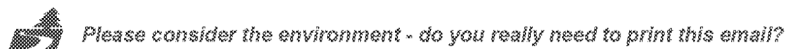

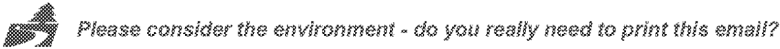
