To be honest, I don't quite follow the logic of Andy Winn's letters (I suspect this is just me and that this makes perfect sense to the SPMRs!).

The risk here is that disclosing any form of an error in Horizon could become problematic if it ends up in the hands of the JFSA. However, we have no real option but to disclose this issue and make right the error with the SPMRs that have been effected. To do otherwise, risks damaging POL's credibility on Horizon and severe criticism from the Fed.

My suggest therefore is to make sure that we fully understand the root cause of this error before going public. Hopefully, this will give us a good explanation as to why this one error does not undermine our general view that Horizon is otherwise robust.

With that in mind, are you happy for me to speak direct to Simon Baker / Andy Winn to get some more background/technical details?

Ben – I suspect that some of this won't make any sense. If so please feel free to give me a call and I'll chat you through the history.
