Susan and I talked about this work today.

I thought this paper was clear and helpful. I am also glad that on the basis of his conversation with Susan last week, Alasdair Marnoch thought that the right immediate issues were being tackled in the right way at the right speed.

I had some thoughts which I want to put on the record about the way ahead.

First, while it is clear that we are committed to using SS for the 47 cases which are already in the frame for their review, it is extremely important that we cap their involvement at that. The moment they are involved in additional cases beyond these, we will have lost the ability to end the relationship with them - an outcome which I do not want to have to contemplate. I understand that this means we have to find a way of satisfying James

Arbuthnot and the JFSA that we have a credible alternative way of handling additional cases. So the sooner we can do this, the better.

Second, we need to pin down and cap SS's costs. I understand from Susan that she has told them that she is expecting them to do the extra work pro bono but no deal has been done. I understand that Chris will be bottoming this out urgently and that there will be a cap on any additional payments to them.

Third, we need a proper process for appointing the independent Chair of the working party. We cannot afford to make the wrong choice here. We need to draw up a clear description of the role and the qualities we are looking for and then interview some people who appear to fit the bill, and reference them properly (ie conversations not bits of paper).

Finally, I have asked Susan to keep the Board fully informed of future developments and to alert me to anything which she is unable to resolve which could get in the way of getting the job done in the way it needs to be done. She will be seeking conversations about all this with all the NEDs on an individual basis and will be in touch with you to arrange these.
